On the occasion of his final meeting as Chair of the Student Affairs Committee (SAC), Interim Student Trustee Batham commended the ASO/ASU Presidents for their outstanding leadership efforts.

# STUDENT TRUSTEE MONTHLY REPORT

Interim Student Trustee Batham reported regarding the discussion that was held at the Board meeting of April 25, 2012 with respect to the moratorium process. He discussed the importance of passing the November tax initiative that Governor Jerry Brown is putting forward. He indicated that the non-passage of this initiative will have a negative impact on community colleges in California. He urged the ASO/ASU Presidents to work together in achieving the passage of this initiative.

With respect to the amendment to the District Curriculum Committee's (DCC) priority enrollment proposal that was adopted at the SAC meeting of March 23, 2012, Interim Student Trustee Batham indicated that the SAC is being asked to "let it go." He indicated that the priority enrollment discussion is scheduled for the Board meeting of June 13, 2012 and stated that later during the SAC meeting, he would entertain a motion to amend the Resource Table Student Representatives for the Board meetings of June 13, 2012 and June 27, 2012 to make him the Student Representative.

Interim Student Trustee Batham responded to questions regarding his report.

## LIAISON REPORTS

# <u>District Office Report</u>

Ms. Bobbi Kimble encouraged the ASO/ASU Presidents to attend the June 13, 2012 Board meeting to voice their concerns regarding priority enrollment. She reported regarding Transfer Model Curriculum (TMC), which was put into law last year by the California legislature. She indicated that this is a guarantee to community college students that if they complete a specific degree program, they will be admitted to a California state university (CSU). She indicated that, according to the latest budget news, the LACCD is scheduled to lose 6,076 FTES next year, which would equal a total net loss of more than \$27 million.

Ms. Kimble commended the ASO/ASU Presidents for their outstanding leadership and professionalism during the SAC meetings.

Mr. Campos indicated that there is an issue at LAMC with respect to student participation during the Academic Senate meetings. He inquired if students are allowed to attend Academic Senate meetings on the campuses and whether these are public meetings.

Ms. Kimble responded that the Academic Senates are Ralph M. Brown Act committees and are open public meetings.

Mr. Eric Kim concurred that the Academic Senate meetings are covered by The Ralph M. Brown Act.

For the record, Mr. Campos inquired as to Ralph M. Brown Act requirements for campus Academic Senates and public speaking therein.

Ms. Kimble indicated that this inquiry will be referred to Mr. Kim, who will follow up with Interim Student Trustee Batham and Mr. Campos.
