REPORTS/RECOMMENDATIONS

April 2013 Follow-up Visits to the Seaside Colleges

West Los Angeles College (President Nabil Abu-Ghazaleh)

Mr. Abu-Ghazaleh reported that West Los Angeles College has fully addressed all recommendations and is in compliance with Accreditation standards.

Los Angeles Southwest College (President Jack E. Daniels III)

A document entitled “Los Angeles Southwest College, follow-Up Report, and Preliminary Findings” was distributed.

Dr. Daniels reported that Los Angeles Southwest College has addressed Recommendation 1 and Recommendation 2. He indicated that the Accrediting Commission of Community and Junior Colleges’ (ACCJC) response to Recommendation 3 from 2012 has been partially addressed, Recommendation 4 has been partially addressed, Recommendation 5 has been partially addressed, and Recommendation 6 has been partially addressed.

Los Angeles Harbor College (President Marvin Martinez)

A document entitled “Los Angeles Harbor College, Follow-up Report Debriefing to the LACCD Board of Trustees” was distributed.

Mr. Martinez reported that Los Angeles Harbor College (LAHC) has fully addressed College Recommendations 1 and 2 and is in compliance with Accreditation standards.

March 2013 Accreditation Visits to the Valley Colleges

Los Angeles Mission College (President Monte E. Perez)

A document entitled “LAMC’s draft External Evaluation Report” was distributed.

Dr. Perez discussed the document with respect to the actions taken to resolve the fourteen recommendations as a result of the accreditation visit of March 2013.

Los Angeles Pierce College (President Kathleen Burke-Kelly)

Dr. Burke-Kelly discussed the four commendations and three recommendations for Los Angeles Pierce College (LAPC) as a result of the accreditation visit of March 2013.
