## I. Status on COVID-19 Public Health Emergency & District Recovery

December 2021 marks the 21<sup>st</sup> month of the worldwide COVID-19 pandemic that was declared a public health emergency in March 2020. Our nation will close out 2021 with a very somber statistic that more than 800,000 people in the U.S. have now died from the disease and more than 5.3 million deaths have been recorded globally in less than two years, according to the Johns Hopkins University <u>website</u>.

The newly emerged, highly contagious Omicron variant of COVID-19 has now raised alarm bells throughout the world. Local, state and national public health officials are expressing concern that they are also seeing signs of another winter surge of COVID-19 cases (attributed to both the Omicron and the Delta variants). In fact, due to a rise in cases in California since Thanksgiving, state health officials on December 13, 2021 announced they have issued a new indoor masking mandate for the entire state effective for at least 30 days, from December 15 to January 15, 2022, regardless of a person's vaccination status. Although included, Los Angeles County is one of the few areas in California that will not be directly impacted by the new state directive thanks to pre-existing local legal mandates for indoor masking already in place via the Los Angeles County Department of Public Health (LACDPH) as well as the District's own Board Policy 2800 mandating indoor masking for the past several months. County health officials have said local indoor masking mandates will remain in place at least through early 2022 especially with two variants of concern (Omicron and Delta) still circulating.

The state, meanwhile, also has now <u>issued new requirements for travel</u> as part of its latest efforts to stop the disease, including:

- All travelers arriving in or returning to California from other states or countries should follow <u>CDC travel guidance</u>.
- All travelers arriving in or returning to California from other states or countries should test three to five days upon arrival here.

 All travelers who test positive or develop <u>symptoms of COVID-19</u> should <u>isolate</u> and follow <u>public health recommendations</u>.

The Delta variant continues to reign supreme as the dominant, deadly form of the COVID-19 virus mutation, accounting for more than 95 percent of all new cases, however, county health officials recently told LACCD Emergency Operations Center (EOC) Command Staff representatives that community transmission of Omicron is likely occurring within the county. It is too soon to say whether or not Omicron will crowd out Delta and how lethal it will be, but the situation is being monitored closely. Fully vaccinated people who have also received a booster shot appear to be vulnerable to Omicron infection, but their illness appears to be mild. Nearly all hospitalizations—and deaths—that are currently occurring are with people who are not vaccinated.

County health officials remain firm in urging all eligible people to get vaccinated or to get boosters now. Everyone, regardless of vaccination status, should be regularly tested, especially if they show signs of illness or if they believe they have been in situations where they could have been exposed to the disease by others. Officials urge extra caution as we enter the year-end holiday celebrations and advise against travel or gatherings for anyone who is not vaccinated. Frequent handwashing; indoor masking; vaccinations/boosters; avoiding crowds (indoors and outdoors) and sensible distancing are all considered best practices to avoid illness, according to county health officials.



Regarding vaccinations, the good news is that on the one-year anniversary of the first COVID-19 vaccination that was given in California, more than 62.7 million doses of the vaccine have now been administered in California since the vaccinations first became available, according to a December 14, 2021 <u>announcement by Governor Newsom</u>. Those doses mean 86 percent of all eligible Californians have received at least one dose. Additional statewide data can be found <u>here</u>.

Locally, LACDPH reports more than 15.2 million doses of vaccine have been administered, including about 7.5 million people with at least one dose; 6 million who are fully vaccinated and 1.7 million people who have received a booster shot. Now that everyone ages 5 and up can receive the vaccination, these numbers equal about 77 percent of all eligible persons (9.7 million people) in the county having received at least one dose of the vaccine. If looking at data included in last month's report for all eligible persons, ages 12 and older, (8.8 million people), the vaccination rate has climbed from about 80 percent who have received at least one dose to 83.4 percent with one dose; and the county's fully vaccinated rate has gone from about 72 percent to 75 percent.

For LACCD, improvements continue in terms of compliance by both employees and students regarding <u>Board Policy 2900</u> for vaccinations, exemptions and testing. The number of employees who are not in compliance has dropped below 1,500 and the Human Resources Division plans to send more follow-up compliance notices to them in December and January as part of the process for progressive discipline. Any student who wishes to enroll in in-person, on-campus classes for the Spring 2022 semester will not be allowed to do so until they are in compliance.

The District's Office of Information Technology has installed electronic scanning stations at all district facilities and the colleges where employees and students can now scan their Cleared4 QR code pass prior to entering any campus or at the District's downtown office building. Testing locations for employees and students with Biocept continues to be provided. Most of the colleges also continue to partner with healthcare providers for free vaccination clinics and East Los Angeles College will continue its partnership with the County as a public testing site through May 2022. 

## **Enrollment Marketing**

Onboarding meetings and initial work with Elder Tree as the new Agency of Record for enrollment marketing and advertising began in November. Elder Tree and the colleges have already initiated some campaigns for Spring 2022 semester while the District is focusing on a comprehensive campaign for L.A. College Promise enrollment in 2022. More details will be reported in 2022 as work on the campaigns occurs.

## III. Foundation for the Los Angeles Community Colleges

### Max the Vax Campaign Update

The Foundation continues to support the District's vaccination efforts for LACCD students with the "Max the Vax" incentive campaign generously funded a grant from Kaiser Permanente.

The Max the Vax incentive campaign provides incentives of \$75 to each student who gets vaccinated and submits an application to the Foundation. Students are eligible for an additional \$75 if they bring a friend or family member to get vaccinated too, while funds remain available. To date, more than 2,000 incentive applications have been received.

## **Donor & Fundraising Info**

The Foundation is processing scholarships, grant awards, and donor reports for the 2021-22 Academic Year. The Foundation is also soliciting new philanthropic contributions and developing initiatives that will support LACCD students during year.

- In partnership with Southern California Edison, the Foundation has awarded 25 students \$1,000 each to support their educational pursuits in Science Technology, Engineering and Math (STEM) majors.
- The Foundation launched the Umoja– AAOI Scholarship to support students participating in Umoja programs
- The Foundation continues to support LACCD nursing students through its Persistence and NCLEX scholarships. These scholarships are designed to remove barriers for nursing students and help them complete their studies.
- In partnership with human-IT, the Foundation has awarded more than 200 mobile hotspots and six months of free internet service to LACCD students. Human-it also hosted a mobile hotspot giveaway at Los Angeles Southwest College. (see photo, right)



## V. Special News, Events and Announcements LACCD Fareless "GoPass" Partnership With L.A. Metro Announced



The nation's largest fareless public transit program for college students was announced December 7, 2021 at a press conference at Los Angeles City College (LACC) by Board President Steve Veres, Chancellor Rodriguez, Metro CEO Stephanie Wiggins, LACC President Mary Gallagher and LACCD Student Trustee Coraima Martinez.

News releases in English and Spanish are posted online. The one-year program provides significant benefits to all LACCD students and eliminates one more barrier for them to complete and achieve their educational goals. The District will continue to advocate for funding at the state and federal levels to make the program permanent for all LACCD students. Special TAP cards and unique access codes have been delivered to all colleges to make the fareless transit option available now. The colleges will be posting distribution info on their websites and sending messaging to students.

Extensive news media coverage occurred from the press conference and in follow-up stories and broadcasts. ## The "Meeting Owl" Has Landed at Los Angeles Pierce College (LAPC)!



The Owl is here! LAPC is working with the District's Office of Information Technology to provide more options for students to learn and faculty to teach with a dual delivery option of taking the same class either in person or remotely by utilizing <u>Owl technology</u>.

According to History Professor and AFT 1521 Chapter President **Brian Walsh**, each dual delivery class will have two sections, one for in-person and one

for remote synchronous delivery. The Meeting Owl makes any classroom a hybrid environment using a camera equipped with a 360-degree lens that captures a panoramic view of the room. Two LAPC instructors piloted the system in their classes this Fall and more classes will be added in the Spring semester. LAPC is the first college in the District to utilize the Owl technology. 

## Jack Fujimoto, Former West Los Angeles College (WLAC) President Dies at Age 93



Jack Fujimoto, Ph.D., a former West Los Angeles College (WLAC) President passed away in November. According to <u>obituary information</u>, in 1969, Mr. Fujimoto was selected as a dean at LAPC and in 1977 he became the president of Sacramento City College, making him the first Asian American to become the president of a mainland U.S. community college. From 1979 to 1986, he was president at WLAC. He became president at LAMC in 1989 and served there until 1996. From 2002 to 2003, he was interim superintendentpresident of Imperial Valley College in Imperial County.

Born in California in 1928, Fujimoto and his parents were sent to the Poston War "Relocation Center" in Arizona in 1941 for

four years. Following his high school graduation, Fujimoto volunteered for the U.S. Army, where he served in Japan during the Korean War. He became the first in his family to pursue a college education and obtained his A.A. degree at Pasadena City College and his B.S., M.B.A., and Ph.D. at UCLA.
