# I. District Updates

Accreditation Status Reaffirmed for All Nine Los Angeles Community Colleges

The Accrediting Commission for Community and Junior Colleges (ACCJC) reaffirmed the accreditation status of all nine colleges within the Los Angeles Community College District (LACCD). The ACCJC conducted a comprehensive review of each individual college and the district office as part of its accreditation process. The accreditation status for each college runs through the remainder of the accreditation cycle to 2023. In 2016, following a week-long series to each college and District Office that involved over 100 educators from California and Hawaii, the ACCJC issued a set of recommendations for improvement and/or compliance with accrediting standards. The LACCD team embraced the ACCJC's recommendations and worked expeditiously to address every issue raised by the Commission and went a step further by going above and beyond the evaluation criteria to determine how we could better serve our colleges and our students.

The accreditation process is integral to maintaining high levels of instructional quality and public trust. The clean bill of health from the ACCJC reflects the progress we have made to strategically invest in our instructional programs, new campus facilities, and new technology resources. We are all to be commended for holding ourselves to high standards for institutional excellence and ensuring the best educational outcomes for our students. I want to thank our dedicated faculty, staff and administrators across all of our nine colleges and District office who devote every day to promoting the success and welfare of our students. The full accreditation reports for each college are available to the public and will posted on each college's website.

#### Jack Kent Cooke Foundation Undergraduate Transfer Scholarship

Twelve (12) students across six LACCD colleges have been named semifinalists for the Jack Kent Cooke Foundation Undergraduate Transfer Scholarship, worth up to \$40,000 per year and renewable for up to three years. The highly selective program receives nearly 2,500 applications each year from community colleges across the country, with 45 scholarships awarded annually. The student finalists are from East Los Angeles College, L.A. City College, L.A. Pierce College, L.A. Trade Technical College, L.A. Valley College and West Los Angeles College.

# DACA/Immigration Task Force Update

On January 25 the DACA/Immigration Task Force co-chaired by LACCD Trustee Gabriel Buelna and Chancellor Francisco Rodriguez met at L.A. Harbor College to continue the work of the Task Force. Ms. Ruby Nieto, Student Financial Aid Programs Specialist with the State Chancellor's office provided a comprehensive overview of the various financial assistance programs and financial services available to undocumented students. She also answered questions about the FAFSA and other financial aid questions that are top of mind for this segment of students. The Task Force agenda also included an update from Mr. Gene Kim with Imprenta Communications on the districtwide social media campaign focused at undocumented students who are currently enrolled, those who have left and not completed their educational goals, and parents of undocumented students. In addition, Apolonio (Polo) Morales, Political Director Coalition for Humane Immigrant Rights of Los Angeles (CHIRLA) gave an insightful presentation on "Advocacy Strategies, DACA Events and Community Activities." This presentation covered the divergent policy positions in Washington, D.C., and provided insight on advocacy strategies underway across the county. The meeting also provided an LACCD legal update from General Counsel Jeffrey Prieto and Associate General Counsel Eric Kim. A push was made - urging DACA-eligible undocumented students to reapply for DACA by March 5, to find out more about the Temporary Protected Status (TPS), and to consult with a lawyer prior to undertaking any action. The Task Force meetings provide an opportunity for faculty and staff to hear from students, and this meeting included the voices of several undocumented students who shared their needs and educational interests. The meeting concluded with networking, sharing of resources and strategizing activities to assist LACCD's undocumented students during these uncertain and difficult times. The meeting was "live video streamed" on Facebook for maximum inclusion and participation. The video was viewed by 539 people and reached over 1,160 individuals. The comments on the LACCD page were overwhelmingly positive with 81 people reacting favorably to the information. The next meeting of the Task Force is scheduled on March 1, from 2:00-4:00 pm at East Los Angeles College.

### LACCD Sacramento Legislative Day

Representatives of the Los Angeles Community College District (LACCD) traveled to Sacramento on January 27-29 to participate in the Community College League of California's (CCLC) Annual Legislative Conference and Advocacy Day. LACCD's delegation led by Board Vice President Trustee Mike Fong, and included Trustee Steve Veres, Chancellor Francisco Rodriguez, Executive Staff and student leaders from three of the nine colleges. The LACCD team met with 35 legislative offices as well as the Governor's office to discuss LACCD's 2018 legislative and budget priorities. The delegation also had sit-down meetings with Senate Pro-Tem Kevin de Leon (D-Los Angeles) and with Assembly Speaker Anthony Rendon (D-Los Angeles). The trip was very productive and enabled the delegation to discuss the District's legislative priorities and to address questions related to the Governor's Community College Budget proposal. Student participation was key and it

enabled our students - through their own personal stories to share the immediate impact of the proposed legislation on their own lives and the lives of their classmates. Their contributions helped to put into context the proposed policies and helped to reshape the conversation in the Capitol.

# Small Business Advisory Council

On January 30, LACCD President Sydney Kamlager-Dove held a meeting of the LACCD Small Business Advisory Council. Trustee Scott Svonkin and Chancellor Francisco Rodriguez also attended the meeting. Participants included representatives from the Chinese American Construction Professionals; Los Angeles Latino Chamber of Commerce; Society of Hispanic Professional Engineers; Construction Management Association of America; Pacific Coast Regional Small Business Development Corporation; Greater Los Angeles African American Chamber of Commerce; Logic Technology; and DHS Consulting. The meeting included an update of the LACCD construction forecast by Mr. David Salazar, Chief Facilities Executive for the District. Stakeholders also discussed the Community Economic Development Program and the 2017 Small Business accomplishments. Participants discussed the Small Business goals for 2018, which include:

- Establishing committees within the council
- Separating opportunities for small business engagement (District and Bond)
- Collection of data, i.e. such as a listing of current suppliers

The next meeting will focus on refining the SBAC goals. The meeting concluded with a roundtable discussion of the upcoming LACCD Build events, including the upcoming BuildLACCD Boot Camp Academy scheduled on February 21, as well as the Advisory Council's future events and activities. The next meeting of the LACCD Small Business Advisory Council is scheduled for April.

### Sexual Assault, Sexual Harassment and Title IX Task Force Update

On Wednesday, January 31, Trustee Hoffman convened the Sexual Harassment and Title IX Task Force at the ESC. Leading the Task Force were co-chairs of the Task Force, Trustee Andra Hoffman and L.A. Pierce College President Kathleen Burke. Approximately 20 Task Force Members attended, including representatives from the bargaining units, LACCD Title IX Coordinators, District executive staff, and guest presenter Kristine Kwong, Partner at Musick, Peeler and Garrett. Ms. Kwong gave a comprehensive overview and Title IX Training on the topic of "Responsible Employees: What You Need to Know and Why." Ms. Kwong's presentation focused on the history and overview of Title IX – intended to assist the Task Force Committee in their review of LACCD Administrative Regulations. The topic generated substantive discussion with questions and answers from Task Force Members. The next two Title IX Task Force meetings are scheduled on February 21 and 28, at the ESC.

- Review of the Title IX Sexual Harassment Report covering District cases from the 2016-2017 academic year,
- Review of the Administrative Regulation C-14 District Procedures. Task Force members were asked to make suggestions and revisions to the District policies. A discussion on proposed policy revisions will occur at the February 28 task force meeting,

- Members were asked to submit real-life and fictional situations or "scenarios" of Title IX situations that need to be addressed. These should be submitted in advance of the next Committee meeting to Vice Chancellor Dr. Albert Roman. The purpose of this exercise is intended to inform the Task Force in proposing revisions to board policy and Administrative Regulation C-14, and
- A Training on hostile work environments, bullying, and harassment in the workplace will be conducted by Kristine Kwong, of Musick, Peeler and Garrett on February 28.

#### Foundation for the Los Angeles Community College

It is an axiom in fundraising that heavy lifting really begins when you receive a contribution or grant. To that end, much of the recent work has involved spending the funds that we received in a way that meets the donor's intentions, is prudent and the results reportable. Below are a few highlights of recent activity.

The intended use of the Ralph M. Parsons grant of \$100,000 for text books presented unique challenges because of the differing levels of text books for students and the business process of each college bookstore. WLAC Vice President Iris Ingram was instrumental in helping coordinate a discussion with the bookstore managers. Ryan Cornner and Maury Pearl provided lists of L.A. College Promise students. We decided to prorate the distribution of funds based on the population of L.A. College Promise students. A list of students by college was emailed to each bookstore manager, followed by a check for the prorated amount. The respective bookstore managers agreed to provide a report by the end of the semester as to how the funds were used. A collective report will be prepared and sent to Ralph M. Parsons Foundation, along with a request for future funding.

Parson's Grant Disbursement per Campus for LA Promise Students

The \$40,000 grant from Edison International was intended for two purposes. One, to provide 10 - \$1,000 scholarships for students in STEM majors at Southwest and West LA College. And two, to implement an online scholarship application process using Next Gen software.

The scholarship application process is now live. The software can be used to set up applications and award scholarship funds for any gift. Edison provided \$7,000 for training for the software to enable other LACCD Colleges to use the product.

The Foundation Board submitted a request for quotes (RFQ) for investment advisors. Five submitted proposals. The committee narrowed it to two firms and we asked to visit their headquarters to meet with their respective teams. At the last Foundation Board meeting the directors unanimously voted to use Payden & Rygel. The selection of an investment firm is important in developing an investment policy and stewarding potential endowment gifts.

Administration of the Vicky Chang grant for Nursing is ongoing. In March, the Foundation will complete the move to a process managed out of the Foundation for the Los Angeles Community Colleges at the district office. The application and awarding process has been honed to meet two goals—to remove the financial barrier students contend with to take the test, and to create an incentive for students to take the test. The process now involves providing a voucher worth \$200 from Pearson Vue to pay for the cost to take the test.

Finally, perhaps the most important development for the future of fundraising is the hiring of a new director of communications and external relations. Vetting of candidates via the Personnel Commission, the interview committee, and upper management is complete. The candidate, William Boyer, accepted the position and is expected to begin on February 28. With this position in place more time, energy and human resources will be devoted to cultivation of donor prospects, foundations and corporations.

We look forward to 2018 as we find resources to remove the barriers to education, increase enrollment and ultimately strengthen the social fabric of our region through education.

### II. Update on the LACCD Enrollment and Strategic Marketing Campaign

The spring semester is underway and district is currently experiencing enrollment declines for 2017/18. Fall semester headcount enrollment and FTES was down approximately 5%. We are trending in the same pattern for spring thus far, but expect gains with our late start classes. Statewide, about two-thirds of community colleges are experiencing enrollment decreases or flat enrollments due to factors such as downward trends in the population of high school seniors and a robust economy that has a counter-cyclical impact on community college enrollments. Districtwide, we have deployed several immediate strategies to counteract this trend. Turning around this current enrollment trend will take all of us, working together, with the common goal of serving our community with high quality instruction, timely support services, and excellent customer service. I am confident that we can do this – our students and community deserve our best.

#### Executive Summary of Social Media Campaign

The LACCD and Interact Communications are engaged in a marketing campaign aimed at increasing enrollment by targeting specific student populations in ways that will produce the highest return on investment (ROI), support retention and encourage re-enrollment, build brand awareness and support, and cultivate community support. Students targeted for this marketing initiative fell into two groups: (1) **Students who failed to appear** were defined as students who previously applied (in Spring 2017, Summer 2017, and Fall 2017) and had not enrolled these semesters and (2) **Students who failed to return** were defined as previously enrolled students who had not yet enrolled in either Winter 2018 or Spring 2018.

Based email distributions as of Feb. 1, 2018, 62,624 students who received an email, social media impression, or were served a digital display advertisement have enrolled. A link within the sent emails directing potential students to the class schedule or to the LACCD enrollment web page has been clicked 41,748 times. The social media campaign has produced 2.8 million impressions with 40,185 individuals clicking through the advertisements to visit individual college websites. As of Day 1 (Feb. 5, 2018 vs Feb. 6, 2017), Spring 2018 headcount was estimated to be 90% of Spring 2017 headcount. Table 1 displays the number of students contacted via email and social media and the contact schedule.

Analytic measures provided by Interact, based on distributions as of Feb. 1, 2018, track both emails and digital media views. Successive email distribution lists remove enrolled students and, based on counts of students dropping off of lists, Table 2 shows that 62,624 students who received an email, social media impression, or were served a digital display advertisement have enrolled.


The proportion of emails opened (Open Rate) and clicks made after the email was opened (Click-Through Percentage) displays this information by college. The 18.1% email Open Rate for the LACCD is well above the industry standard for higher education (13.4%), while the click-through rate of 2% is well below industry standard (8.5% for higher education and 3.4% for all industry).



The social media campaign has produced nearly 2.5 million impressions with over 36,000 students clicking through the advertisements to visit individual college websites.

Student headcount enrollment trends and daily enrollment changes are shown for Spring 2017 and Spring 2018, respectively, in Charts 1 and 2 below. On Day -56 (Dec. 11, 2017 vs Dec. 12, 2016), which corresponded to the week following the launch of the marketing campaign, Spring 2018 headcount increased noticeably compared to Spring 2017 and has been on par with Spring 2017 until Day -14, when headcount increases outpaced those in the prior year. As of the first day of the Spring semester (Feb. 5, 2018 vs Feb. 6, 2017), Spring 2018 headcount was estimated to be 90% of Spring 2017 headcount.





# III. Reports from the College Presidents

#### Los Angeles Harbor College

- Internships: Eight (8) students are scheduled for BuildLACCD interviews; Eight (8) students have applied for an internship at the Port of LA; Nineteen (19) internships sites have been identified for Internship placements; six (6) students are participating in winter-term internships with the following locations: Gangs Alternative Program (GAP), Rancho Los Cerritos Historic Site, and Transhealth Medical; a total of 72 students have completed "internship readiness;" and three (3) Harbor Advantage students (to date) have submitted applications for NASA/JPL summer internships with the support of STEM staff.
- Harbor's HTPA (Harbor Teacher Preparation Academy) received the National Blue Ribbon Award (the Federal Government's highest award for academic achievement) on January 18, 2018. We are the top rated High School in LAUSD.

### Los Angeles Mission College

- The California Wellness Foundation has awarded LAMC a \$250,000 grant to expand the college's educational programs provided to L.A. County Probation youth. In partnership with L.A. County's Probation Department and Communities in Schools, a nonprofit devoted to helping youth achieve success. The college will use the funds to establish the College Culture Re-Entry Hub that will coordinate the credit courses the college provides at many of the County's camps and juvenile halls.
- Los Angeles Mission College hosted the Spring Registration Days event from January 18<sup>th</sup> to January 19<sup>th</sup> to provide students with one-on-one assistance with registering for classes, and access important services like Counseling, Admissions, and Financial Aid.
- President Monte Perez and Genil Washington, director of Talent Acquisition for Dignity Health, led a panel discussion on the future of work within health care on January 24. More than 40 students, community members and industry partners attended and asked questions regarding local employment opportunities and educational requirements.
- The Financial Aid and Scholarships office has announced 25 scholarships available to L.A. Mission College students. The application cycle will take place from February 5 through March 23. Students can apply for a variety of scholarships, including graduating; transferring; full-time and part-time; Art; Veterans; Women; Child Development; San Fernando Food and Wine; Foster Youth and more.
- As part of the Welcome Week activities, the Transfer Center will host representatives from more than 12 colleges, including UCLA, UC Irvine, CSUN, and Mount Saint Mary's University to speak with students and provide transfer requirements.
- LAMC Theatre Presents Peter and the Starcatcher from March 15 through March 24.

#### Los Angeles Trade-Tech College

 At the California Board of Governors meeting in Sacramento on January 16, the board along with the Academic Senate of the California Community Colleges bestowed just two Exemplary Program Awards to community college pathways. One of the honors went to Los Angeles Trade-Technical College for its work on LATTC's Advanced Transportation and Maintenance Pathway. Pathway chair Jess Guerra was on hand to receive the award and to talk about the transformational strategy and success of this pathway for students.

Los Angeles World Airports has awarded the contract of Automated People Move to the LINXS team. The agreement includes LATTC's role as the primary training provider for the maintenance of both the People Mover transit facilities and the robot train itself.

 On January 26, La Opinion reporter Jacqueline Garcia included an interview with an LATTC DACA student from the Dream Resource Center for the LACCD DACA News Conference. The story talks about the LACCD's financial support of DACA students district-wide. The student also stated the uncertainty of the federal commitment to DACA makes students uneasy.

#### Los Angeles Valley College

- Town Hall on Homelessness: Los Angeles is facing an unprecedented homelessness crisis. Elected officials, government agencies and non-profit organizations are working on finding solutions to end homelessness. Councilmember Paul Krekorian and Community Policy Advisory Board held an informative town hall meeting on January 18 at Monarch Hall. The meeting was well attended with over 400 people participating. The meeting featured a panel of leaders from city, county, and state agencies, along with non-profit service providers, who addressed questions on homelessness in Los Angeles. Speakers included:

- LAVC hosted the LGBTQ President's Conference on January 19 20. A total of 19 president from across the nation attended the conference. The organization's mission is effective leadership in the realm of post-secondary education supporting professional development of LGBTQ leaders in that sector, and providing education and advocacy regarding LGBTQ issues within the global academy. At the conclusion of the meeting, Dr. Erika Endrijonas was elected as the Co-Chair of the LGBTQ Presidents in Higher Education.

- Breaking into the Entertainment Industry: Assemblymember Adrin Nazarian held an event at LAVC on January 25 with the International Alliance of Theatrical Stage Employees (IATSE), the union behind entertainment workers. This event was free and open to the public. Over 200 people attended and learned from individuals who are:
  - Electrical lighting technicians
  - Production sound and video engineers
  - Script supervisors and production specialist
  - Costume designers
- LA Valley College's Family Resource Center partnership was nominated for the prestigious Bellweather Award in the Workforce development category. Although the program did not receive the national award, it placed in the top 10. The team included college representatives and Trustee Andra Hoffman.

#### West Los Angeles College

The California Community College Chancellor's Office has awarded two grants totaling \$1,000,000 to West Los Angeles College and Torrance/based Southern California Regional Occupational Center. WLAC will find an employer-centric Aero/Flex Pre-Apprenticeship track for advanced manufacturing. Additionally, WLAC will work with the South Bay Workforce Investment Board to expand the existing Aero-Flex Pre-Apprenticeship program—the first aerospace apprenticeship in the nation—to enroll 100 pre-apprentices who will earn valuable experiences at such partner aerospace industries as Northrop Grumman.
