#### INTRODUCTION

The month of June 2020 may be remembered as one of the most significant periods in the history of the Los Angeles Community College District (LACCD). The 30 days of June were marked by a dizzying pace of significant first-ever milestones and achievements; the tragic loss of one of our students; new hope for students; plans for recovery from the pandemic and the clarion call for racial equity and social justice. Among the many activities, events and accomplishment were:

- Surpassing more than 100 days of continuous emergency operations for the District and its colleges—the longest such emergency response in the District's history
- Successful completion of the first-ever, all-remote learning/online semester with about 10,000 classes taught in remote learning environments at the nine colleges
- Nine first-ever virtual recognition ceremonies in one day celebrating the Class of 2020 that, together with two other special online events for Black Graduation and Lavender Graduation celebrations for African American and LGBTQIA+ students, saw more than 10,000 students, faculty, families and friends participating in these celebrations
- The police-shooting death of an LACCD student from Los Angeles Trade-Technical College that occurred off-campus and remains under investigation in the midst of a national movement for large-scale reform in law enforcement
- A stunning series of positive decisions by the U.S. Supreme Court giving new hope to the rights of DACA and other undocumented students and affirming workplace rights for the LGBTQIA+ community
- Initial completion of pandemic recovery planning documents, policies and other logistic plans for a return to on-campus activities
- Development of a new Framework for Racial Equity and Social Justice for LACCD

All of these occurred against the backdrop of the COVID-19 public health emergency, the worst worldwide pandemic of our lifetime that has infected nearly 12 million people globally; killed almost 550,000; crippled nations and wrecked the economy.

Yet, the District—bowed, but resilient—remained open in June—and has remained open since the health emergency began in March—to continuously provide quality, affordable higher education, full business services, regular employment and ongoing capital improvement construction at the colleges.

## I. District Status on COVID-19 Public Health Emergency

As noted in the Introduction, LACCD's status is, and remains, open and operational. The District never stopped providing education or business services, but shifted everything possible to remote learning and online operations. This was made possible in large part due to the establishment of the District's Emergency Operations Center (EOC) and the Incident Command Centers (ICC) at the nine colleges. In addition, special recognition must go to the District's faculty for their outstanding *esprit de corps*—as well as to all District/college staff and collective bargaining leadership—in carrying forward the District's critical mission of service to our students.

On June 29, LACCD hit the 100-day milestone of emergency response to the Coronavirus health pandemic, the longest such activation of its EOC in the District's history. Although the EOC initially operated 24/7 during the initial response to the public health emergency, work in June proceeded on a three-day weekly schedule—with additional days as needed—to coordinate with the colleges' ICCs.

The EOC structure provides the framework for the District to purchase, manage and deploy resources such as Personal Protection Equipment (PPE) and technology; coordinate the District's educational mission and professional development needs; conduct contract tracing of reported illness; establish districtwide recovery policies and safety advisories; develop and distribute internal and external communications and emergency public information; track, analyze and advocate for COVID-19 related legislation; distribute emergency funding, and many other activities that require EOC oversight which have been documented in prior reports.

The Spring 2020 Semester successfully concluded in June, culminating in nine virtual recognition celebrations in one day for students of the Class of 2020 at each college, plus additional online ceremonies, including the annual Black Graduation and Lavender Graduation. Most ceremonies remain viewable via social media platforms.

An assessment is being done to determine new work schedules for both the EOC and the ICCs that could see a further reduction in operations to two days per week, or less, depending on District needs and other factors. It is unknown how long the public health emergency—and the subsequent emergency declarations—will last for Los Angeles County and California, especially now with the large resurgence of cases and deaths in the county and throughout the state and nation that occurred in June and currently continues unabated in July.

While the Los Angeles County Department of Public Health (<u>LACDPH</u>) indicated in June that the county had moved into Stage Three of its Roadmap to Recovery, many aspects of the recovery and re-opening are now temporarily paused due to the renewed outbreaks and spikes in cases.

The detailed, updated health orders from LACDPH, effective July 4, are available online.

There remains no specific timeline for when colleges and universities in Los Angeles County or elsewhere in the state will be allowed to resume full on-campus instruction, related student activities, organized athletics or business operations. The authority remains at the state, which then will allow, per county, the ability for Institutes of Higher Education (IHE) to resume inperson operations, according to LACDPH officials.


In June, LACDPH did provide an update to allow limited, on-campus instruction that could occur pertaining to education for students within the essential services fields, primarily healthcare. The District's efforts for such on-campus instruction are noted below as part of the update on Recovery.


Reporting of COVID-19 cases for the District remains active. As of July 7, 2020 there were:

- 91 reported positive cases
- 1 fatality
- 32 suspected cases
- 56 possible exposure cases

All cases are tracked and followed-up on via the EOC Safety Officers in coordination with the colleges or other District facilities and the BuildLACCD program as needed. Notices are sent out to personnel at specific colleges or facilities and both closures and cleaning are done as part of the response.

As of July 7, the most current numbers for <u>Los Angeles County</u> in its revised online display format (below) show more than 120,000 cases and 3,500 deaths while <u>California statewide</u> is reporting nearly 278,000 cases and more than 6,440 deaths.






# II. Status of Recovery Plans

The District currently remains in its own self-defined Stage 1, as illustrated below, and is in the active planning phase to move into its Stage 2, when allowed by county and state health officials.

## LACCD REOPENING PLANS



Plans and logistics are currently under review for the colleges to begin a very limited return to some on-campus instruction for classes that could not be completed in the Spring 2020 semester, specific for allied health career fields as now permitted by the LACDPH. They are part of approximately 125 classes out of about 10,000 that could not be completely shifted to remote learning. It is estimated that this could occur in mid- to late-July.

The current spike in positive cases and community spread data indicators could negatively impact these plans, however. A new telebriefing for IHE representatives with LACDPH is scheduled for July 8 and is expected to provide additional updates on the County's plans that have seen renewed closures and a temporary pause to some of its recovery plans. Updated public messaging from the County is being used to emphasize personal safety that can assist in recovery efforts is being distributed.



Significant documentation and preparations for moving into Stage 2 has now occurred, placing the District on a quick pace for resumption of on-campus instruction when possible. An updated general Pandemic Plan has been created along with a companion (draft) Coronavirus Recovery Plan that also includes the districtwide Recovery Policies; EOC workflow matrices and the colleges' unique detailed plans for the initial return to on-campus instruction per college.

A new safety advisory for contact tracing of people entering the colleges is being finalized along with the development of a web-based symptom self-check survey that will be completed prior to entry. These steps will be critical to managing the flow of people entering and leaving the colleges when activities will return.

All current Safety Advisories and Recovery Policies are already now <u>curated at the same</u> location of the District's Coronavirus webpages for one-stop reference. The policies cover:

- Athletics
- Community Services
- High School/Dual Enrollment
- Equipment for Home Use
- Child Development Centers
- Hard-to-Convert Classes

When completed, the full Pandemic and Recovery Plan documents will be posted online in July as well.

In addition to District-specific plans and documents, LACCD remains involved in state, county and city recovery planning groups. Key representation for the District has been provided by

Chancellor Rodriguez. Within the past week, the following recovery documents and reports have been issued noting LACCD participation, including:

- California Community Colleges Safe Campus Reopening Workgroup
- County of Los Angeles Economic Resiliency Task Force, Education Work Team
- City of Los Angeles COVID-19 Higher Education Working Group

These reports are being distributed for analysis and consistency with the District's internal plans, along with the recently issued memo from State Chancellor's Office supporting continuity of education programs for the state's essential critical services workforce.

As required by the federal CARES Act, each college is now also posting information online regarding how the colleges are distributing federal emergency aid for recovery. The District has taken those individual web pages and listed the unique locations on a <u>single page</u> within the Coronavirus site, also as a one-stop reference for recovery documentation.

On a statewide level, California continues to remain in Stage 2. The state is working to balance the needs of individual counties while also protecting the public health and safety. In some cases, new closures have occurred per Governor Newsom's orders in more than 15 counties.

The State also adopted its budget for the 2020-2021 Fiscal Year, including fiscal responses related to the COVID-19 emergency. Chancellor Rodriguez issued a statement June 30 helping to explain the state budget and its impact on LACCD and community colleges.

# III. Updates on LACCD Enrollment / Marketing for Enrollment

## 1. Enrollment Update

## A. Summer 2020 Districtwide Credit Enrollment Comparison

As of Day +15 of the Summer semester, comparing Summer 2020 (6/30/20) to Summer 2019 (6/25/19):

- Headcount is 8% higher
- Duplicated Enrollment is 9% higher
- Credit Section Count is 1% higher
- Enrollment per Section is 8% higher

Nearly all colleges have enrollment exceeding 100% of the previous summer and several colleges are experiencing double-digit increases. In addition, the district-wide fill rate of classes for Summer 2020 is 85%.

#### B. Fall 2020 Enrollment

Based on the first day of open enrollment in Fall 2020 (7/1/20) and Fall 2019 (5/28/19):

- Headcount is 3% higher
- Duplicated Enrollment is even
- Credit Section Count is 7% lower
- Enrollment per Section is 8% higher

Sections in Fall 2020 are reduced mainly due to "hard to convert" courses not being scheduled. The Office of Educational Programs and Institutional Effectiveness (EPIE) willcontinue to monitor enrollments and SCFF metrics.

## C. 2019-20 Student Centered Funding Formula (SCFF) Metrics

- Credit FTES is even with prior year
- Total FTES is 0.5% lower than prior year (due to outstanding non-credit FTES)
- AB540 student count is 3.7% lower than prior year
- Promise Grant count is 3.6% lower than prior year
- Pell Grant count is 6.8% higher compared to last year
- Total FTEF is 1% lower than prior year

After full reporting of positive attendance hours, the District is expected to report 300 to 500 additional FTES for apportionment in 2019-20 compared to 2018-19.

# 2. L.A. College Promise Welcome Kit Update

The first-ever "Digital Welcome Kit" for the L.A. College Promise Program produced by the District's Communications Office has been widely distributed to high school students in Los Angeles County. More than 40,000 emails were sent to L.A. Unified School District high school seniors and their parents, along with emails to 70 charter schools that serve an additional 40,000 students.

Other email distributions were completed to students with the Alhambra, Culver City and Burbank school districts and a Facebook campaign on the District's account has reached an additional 73,000 viewers as of July 6.

#### THE IMPACT

Students share how the funds have made a difference.



"I am a single mom of three children and work has been very slow. I am slowly finishing school and taking semesters whenever I can. With this COVID19 stay at home order, every bit helps."

"My son is my first priority... I would chew gum as a meal replacement any day if it means he gets what he needs. School expenses and time consumption of classes have not been the easiest to accommodate, but proyer goes a long way when you feel like the scales are not balancing correctly. This lifnancial award brings joy to my heart... I can buy food with a shelf life so I can spread out meals."

"Since this COVID-19 pandemic has had effects on everyone in the world, it had also affected my family as well. My husband is currently unemployed due to COVID-19 and have 2 children in grade school. I can now use this money to help pay for some graceries that are needed."

"I am a single mother of 3. Currently I am homeless and unemployed due to the Coronavirus. What I have learned living in this Criss is that Life is not easy... Life will knock you down and you can either stay with your face on the ground or you and chose to get back up and fight. I chose to get up and fight. I am a survivor. I will get through this. You see you don't know how strong you really are until that's the only choice you have. With the help from this Scholarship I can have access to my online classes and any other resources that I need."

"In this time of hardship, I have found myself overly stressed of what the future holds for myself and family. I am unemployed and with the recent events my husband is also currently unemployed. I am a serior in the East Los Angeles College nursing program and with this scholarship will be able to pay the fees required to take the National Council Licensure Examination."

"Due to the pandemic I have lost my part-time job which forced me to become homeless, or a starving student as I like to call it, so it doesn't sound so negative. I am trying to keep my head up during these hard times. One thing that brings a huge smile to my face is when humanity proves itself good and there are people like you who reach out to help the community. Words are not enough to thank you for this scholarship."

"I am homeless...this scholarship is very important to me to pursue my studies since I do not receive any financial assistance because I am undocumented. I thank you for the much needed financial assistance and assure you I will do well in school with your investment." "I recently discharged parole [2 years] after serving an 18-year sentence which is where I started my College journey in 2013. While in prison I enterned A sosciates Degree & finishing up here at LACC as a Psych Major. This lagato is important to my success because without it I would have not been able to finish my requirements, especially during the Corona Virus pandemic."

"During this pandemic as we merged to online, I was not sure I could finish my classes or if I had to drop out withdraw. I am a snigle mam of I tow kids who also had to merge their classes online and it was getting more difficult to show up to zoom classes, turn in project or even do assessments. I feared I was falling behind. This will truly make this merge a whole lot easier even as I take summer classes."

"I am currently a single low-income mom, who is in a sober living program. I had my daughter when I was sixteen and through the challenges dropping my education has never been an option...As I'm completing my education a laptop will help in many ways."
