# II. District Status on COVID-19 Public Health Emergency & Recovery



#### **Vaccination Clinics**

LACCD's colleges hosted more than 60 COVID-19 vaccination clinics for students, employees and the surrounding communities during June and more clinics are planned for July in cooperation with the Los Angeles County Department of Public Health (LACDPH). Each of the nine colleges hosted one or more event, providing space, staffing and other resources to assist vaccine providers.

Many of the colleges are providing students with incentives to get vaccinated such as food debit cards and credits to the college bookstores. In addition, the Foundation for the Los Angeles Community Colleges has received a grant from Kaiser Permanente to give LACCD students up to \$150, while funding lasts, to get vaccinated. Details online.

Anyone age 12 or older is eligible to be vaccinated and the clinics at the colleges are open to all, with no appointment needed. The District's recent <u>news release announcement</u> that Los Angeles Valley College was providing an additional \$75 bookstore credit on top of the Foundation's "Max the Vax" incentive generated extensive news media coverage about the efforts by the District and the colleges.

## **Demobilization Efforts**

The District's Emergency Operations Center (EOC) and the colleges' Incident Command Centers (ICCs) have moved into the demobilization phase of the response to the COVID-19 pandemic. Debriefing meetings will be held throughout July and August as part of the process to prepare an After Action Report and Improvement Plan that is anticipated to be finalized in September.

# California Re-opening Began June 15

The District and the colleges have closely followed California's economic re-opening and the changes in health orders and other protocols for Institutes of Higher Education. All of the health protocols by the LACDPH specific to colleges and universities have been retired, however, general <a href="health orders">health orders</a> (most recently updated June 28, 2021) for all remain in place and there have been no announcements yet by California or Los Angeles County officials on exactly when emergency declarations will be rescinded.

With the re-opening and the lifting of many health protocols, LACCD is now allowed to increase more in-person, on-campus classes, student activities and business services at the colleges for the Fall 2021 Semester.

# **Safety Remains Our Priority**

In keeping with changes by the LACDPH, the California's Department of Public Health, the Centers for Disease Control and Cal OSHA, an updated message to all employees was distributed June 29 regarding the District's processes and adherence for self-screening, masks, social distancing and cleaning, including:

# Self-Screening

Online self-screening for COVID-19 symptoms/precautions remains in force until further notice for all employees, students and visitors. Everybody who visits the colleges or District facilities must continue to self-screen until further notice using the SAFE app for the colleges or the forms found online. The District is still required to report any confirmed cases or outbreaks of COVID-19 to the state and county, as well as to persons possibly exposed, and your cooperation is needed to ensure compliance.

# Masks/Facial Coverings Indoors

On June 28, 2021, the <u>LACDPH issued new recommendations</u> that everyone, *regardless of vaccination status*, should wear masks indoors in public places as a precautionary measure to protect against the rapidly spreading "Delta" variant of COVID-19. Public Health strongly recommends people wear masks indoors, including in the workplace.

All employees, students and visitors must continue to wear mask/facial coverings indoors until further notice, regardless of vaccination status. LACCD is now reviewing self-attestation processes, which may allow vaccinated persons to not wear masks, but until a new process is implemented, you must continue to wear masks indoors, except for:

- Persons sitting alone in a private office or workspace where a door can be closed
- Persons eating/drinking in a common area and sitting more than six (6) feet apart
- Persons with a medical condition, including mental health or disability, that prevents
  wearing a mask, and persons who are hearing impaired, or communicating with a person
  who is hearing impaired, where the ability to see the mouth is essential for
  communication

Current LACDPH <u>Health Orders</u> specifically state that all persons, regardless of vaccination status, must wear masks indoors for all healthcare/health center operations; childcare settings and any business or government office serving the public that requires everyone to wear a mask.

## **Masks/Facial Coverings Outdoors**

Both the State Department of Public Health and LACDPH have changed outdoor mask requirements to match the Centers for Disease Control and, in general, <u>people do not need to wear masks when outdoors</u>. However, people who are <u>not fully vaccinated</u> are encouraged to wear a mask in crowded outdoor settings or during activities that involve sustained close contact with other people who are not fully vaccinated, including athletic competition.

#### **Social Distancing**

Effective immediately, there are no longer any mandatory social/physical distancing requirements, however, all persons are allowed to social distance as a personal choice for added protection. In addition, there are:

- No capacity restrictions on classrooms, conference/meeting rooms or offices, including counseling offices, labs and libraries
- No requirements or recommendations for barriers such as acrylic sheeting—although what has been installed may remain in place and any future work is subject to local decisions

## Cleaning

Effective immediately, there are no longer any special cleaning/disinfection of physical workspaces required—exceptions for verified cases of persons testing positive for COVID-19 who were at a LACCD worksite while contagious. In those cases, areas will be cleaned and sanitized in addition to the enhanced cleaning operations already developed by the District.

# **Mandatory Training for Post-Pandemic**



And additional all-District notice was sent out July 1 regarding the District's state-mandated COVID-19 safety training. This training must be completed by August 1, 2021, however, LACCD faculty (only) have until September 30, 2021 to complete it. The training is done online (Start the COVID-19 Safety Training) and takes about 60 minutes to complete.

#### III. Updates on LACCD Enrollment & Marketing

#### **Enrollment**

#### A. Summer Enrollment

Comparing Summer 2021 (7/1/21) to Summer 2020 (7/2/20) as of Day 17 of the semester, for the District as a whole:

- Headcount is at 84%,
- Duplicated Enrollment is at 82%,
- · Credit Section Count is at 104%, and
- Enrollment per Section is at 79%

#### **B. Fall Enrollment**

- 1. Comparing Fall 2021 (7/1/21) to Fall 2020 (7/2/20) as of Day -60 of the semester, for the District as a whole:
  - Headcount is at 101%,
  - Duplicated Enrollment is at 97%,
  - Credit Section Count is at 103%, and
  - Enrollment per Section is at 94%

Due to COVID-19 pandemic, registration timelines for both Fall 2020 and Fall 2021 were delayed and compressed compared to the regular registration timeline for Fall term and that the Fall 2021/Fall 2020 comparison is overstated at this point in time.

Priority registration and open enrollment for Fall 2021 started about two (2) weeks earlier compared to Fall 2020, but compared to Fall 2019 (the regular registration timeline), Fall 2021 priority registration and open enrollment started about three to four weeks later. Therefore, the Fall 2021/Fall 2020 headcount and enrollment comparisons are overstated while the Fall 2021/Fall 2019 headcount and enrollment (developed as an alternative indicator) is understated. It is expected that the Fall 2021/Fall 2020 comparison will normalize and become a more meaningful indicator of relative day enrollment at the beginning of August 2021.

- 2. Districtwide, an average of 24% of Fall 2021 classes are being offered in-person and both hybrid and remote classes are filling at a higher rate than in-person classes.
- 3. The District is preparing the 2020-21 annual FTES report (due to the state Chancellor's Office on July 15, 2021) and is estimating that this will be approximately 85,000 FTES. This represents a 13.9% decline from 2019-20.

#### C. District-wide Enrollment Marketing & Advertising Campaign

The districtwide Summer Campaign concluded at the end of June and is now transitioning into the Fall Campaign that will run through about September 7. Statistics on the Summer Campaign should be available in August. Many of the colleges also continue to do specific niche enrollment campaigns.

Two special online enrollment and information sessions for the <u>Los Angeles College Promise</u> program have been planned and promoted by the District, on June 24 and July 15. <u>News releases</u> and social media messages have been distributed for the sessions.

# IV. Foundation for the Los Angeles Community Colleges

Michael Fuller, Director of Institutional Advancement, announced that the Foundation or the Los Angeles Community Colleges received in June \$125,000 of a \$250,000 grant from Kaiser Permanente for its "Max the Vax" program to provide incentives for LACCD students to get vaccinated against the COVID-19 virus. To date, about 90 previously unvaccinated students have already benefited from the ongoing incentive program.

The Leonetti/O'Connell Foundation continues its generous support with a recent check of \$150,000 for the first half of a \$300,000 grant to be used for emergency grants for Los Angeles College Promise students.

The Foundation was recently featured in *Currents* magazine, a publication of CASE, the premier global non-profit association for educational advancement and fundraising. https://www.case.org/resources/issues/july-august-2021/food-families

Congratulations are due to Foundation Board member Abigail Marquez upon confirmation of her appointment by Mayor Eric Garcetti as the first General Manager, Community Investment for Families Department for the City of Los Angeles. Garcetti made the announcement June 30. Marquez will work closely with the Mayor and City Council to establish poverty-reduction goals for the City; play an active role in implementing homelessness prevention programs; oversee the implementation of L.A.'s Guaranteed Basic Income pilot, the largest in the nation; and implement the Children's Savings Account program, OpportunityLA, which will support 35,000 first-graders annually across the region, according to the announcement.

Applications are due August 1, 2021 for student scholarships via the Los Angeles Southwest College Foundation. <u>Details online</u>.
