## I. District Status on COVID-19 Public Health Emergency & Recovery

The District, its Emergency Operations Center (EOC), the nine colleges and the colleges' Incident Command Centers (ICC) surpassed the seven-month milestone on October 19, 2020 for emergency response operations due to the COVID-19 public health pandemic.

More than 240 people from throughout the District have logged thousands of hours as EOC and ICC first responders in service to the LACCD community to help keep personnel safe and to facilitate the District's historic shift to remote learning and online business operations. Recognition of personnel is planned for the November 2020 Board of Trustees meeting.

The EOC-ICC response teams have been responsible for all aspects of emergency response, including, among others:

- Development of protocols and advisories for health and safety for District personnel and students
- Liaison with state and county Public Health officials for guidelines specific to Institutes of Higher Education in response to the pandemic and for recovery
- Development of District recovery plans and policies
- Proactive contract tracing of reported cases
- Management for the ordering and deployment of personal protection equipment and other emergency supplies
- Creating guidelines for access to the colleges and District facilities
- Providing the framework, software and training to shift educational instruction to remote learning platforms
- Safety messages, emergency public information and media relations
- Training for Incident Command certifications and training for cleaning and other efforts
- Coordinating of emergency expenditures and oversight of expenditures
- Legal, business and operational review and approval of outside requests for access to campus facilities for business continuity
- Coordinate limited return to on-campus instruction Fall 2020 semester

As a result, these emergency efforts have help contributed to keeping reported cases within the LACCD community low. Currently, accumulative totals of known positive cases for personnel and students that have been reported to the EOC is less than 200 since the pandemic began in March.

In Los Angeles County, the countywide numbers of positive cases have exceed 310,000, with more than 7,070 deaths. Los Angeles County is currently the nation's leading Hot Zone of the disease with more confirmed positive cases and attributable deaths than anywhere in the United States, according to tracking data from Johns Hopkins University.

Numbers are reported to be surging throughout the country and around the world as a new wave of COVID-19 cases are being tracking by the university. The United States leads the world with cases, at 9.36 million and almost 233,000 deaths. India has 8.26 million cases, second most; while Brazil is second in terms of deaths at 160,253. More details shown in the graphic below from Johns Hopkins.



Unfortunately, the continued widespread community transmission of the coronavirus in Los Angeles County means the county will continue to be in California's most restrictive Tier 1 status as shown on the chart below. For example, the numbers released by the County for Nov. 2 show there were 1,224 new cases reported during the past 24 hours. To move from Tier 1 to Tier 2, new cases per day for L.A. County need to be at or below 700 and stay that low for two weeks in a row.



Despite these challenges, the District and its colleges were able to begin limited, on-campus instruction for essential services workforce education beginning with the Fall 2020 Semester and all indications are that this type of instruction will continue for the Winter and Spring 2021 semester. For remaining operations, the District anticipates the current mode of remote education and online business services will continue through the Spring 2021 semester.

While no additional on-campus instruction is anticipated to be allowed by health officials until sometime next year, the District is pursuing additional options to provide students with WiFi hotspot access or fiber optic connectivity at the colleges to augment learning. The concept would be to use a parking lot or parking structure(s) where students could park and use free access to Internet while staying in their vehicles. The District's Office of Information Technology has been evaluating sites per college. If any sites are viable, access plans will be developed with the goal of providing connectivity for the Spring 2021 semester or sooner if possible.


In support of the November Presidential and General Election on Nov. 3, 2020, all nine colleges successfully worked with the County Registrar of Voters for public Vote Centers that operated from October 24 to Election Day, Nov. 3. The Vote Centers operated under county health direction for facial coverings, social distancing and other safety protocols and were isolated from other on-campus activities. With only a few exceptions and logistical challenges handled by the County elections team, operations at the Vote Centers were carried out as planned.

The colleges also were used as sites for the County mail-in ballot drop off boxes. All boxes were successfully stationed, signage provided and no issues were reported

Adjustments continue to be made to the operational work cycles for the District's EOC and the colleges' ICCs. Currently, workdays are set on Tuesdays and Thursdays, but scaled back operations are anticipated during the upcoming Holidays through January 15.

A new work group has been formed to begin an analysis of future roles and responsibilities of the EOC and ICC operations

Moving forward, the EOC's Planning and Intelligence Section is also looking at long-range planning for District operations assuming the crisis continues into the Summer session and the 2021-2022 Academic Year.

## II. Updates on LACCD Enrollment / Marketing for Enrollment

## A. Fall 2020 / Fall 2019 Enrollment Comparison

Comparing Fall 2020 (10/28/20) to Fall 2019 (10/23/19) as of **Day 58** of the semester, for the District as a whole:

- Headcount is at 92%,
- Duplicated Enrollment is at 88%,
- Credit Section Count is at 91%, and
- Enrollment per Section is at 97%

Compared to last month's report (Day 34), headcount and duplicated enrollment increased by 1 percentage point primarily due to increased enrollment in late start classes.

## B. Winter/Spring 2021 Enrollment

- Winter 2021 priority registration started on October 19, 2020 and open enrollment will begin on November 16, 2020
- Spring 2021 priority registration will start on November 9, 2020 and open enrollment will begin on December 7, 2020
- A Winter/Spring Enrollment Campaign is planned with the District's advertising agency of record to begin the week of Nov. 9 and will run through February 7, 2021.

Specifically, about one month for Winter and two months concentrated on Spring 2021 with some overlap. The target audiences will focus on retention of existing students; dual enrollment; existing CSU students wanting LACCD classes and then new students at large. There will also need to be elements added for the new Spring L.A. College Promise enrollment.

## III. Foundation for the Los Angeles Community Colleges

The Foundation for the Los Angeles Community Colleges received an anonymous contribution of \$100,000 to support emergency grants for District Nursing Students.

To-date, \$20,000 has been raised for the Undocumented Student Success Fund. In October City National Bank contributed \$10,000. The Foundation has also received \$35,500 from the state foundation for COVID-19 Nursing Grants. The Foundation is using NextGen scholarship software to quickly distribute these funds to nursing students as all awards must be disbursed by November 24.

The Foundation continues to fundraise for the Dreamers Success Fund. This fund will provide direct support to DACA recipients and other undocumented students to cover their basic needs. The Foundation and LACCD are committed to standing with our students in pursuit of their educational goals.


