COVID-19 / STATISTICS

As of November 4, 2020:

- U.S. and the world remain in grips of COVID-19 public health pandemic. New wave of cases/death world wide, prompting shutdowns in Europe and elsewhere
- In two weeks, on Nov. 19, LACCD will be at eight months of emergency operations for the District and Nine Colleges
- National toll of more than 233,000 deaths and 9.36 million positive COVID-19 cases
- District totals remain low, less than 200 confirmed cases
- L.A. County with more than 7,070 deaths and 310,000 cases
- Fall 2020 Semester with some limited, on-campus instruction
- Educational delivery and business operations will remain in remote environments and online for Winter and Spring 2021

Duties & Work Accomplished Since March 19, 2020:

- Develop protocols & advisories for health and safety for District personnel and students
- Liaison with state and county Public Health & government officials guidelines and advocacy specific to Institutes of Higher Education during pandemic
- Develop District recovery plans and policies
- Proactive contract tracing of reported cases
- Manage ordering and deployment of personal protection equipment and other emergency supplies
- Create guidelines for access to colleges and District facilities
- Provide the framework, software and training to shift educational instruction to remote learning platforms



Duties & Work Accomplished Since March 19, 2020:

- Provide framework, software & training to shift educational instruction to remote learning platforms
- Produce safety messages, emergency public information and coordinate all media relations
- Provide training for Incident Command certifications and training for cleaning and other efforts
- Coordinate emergency expenditures, contracts and oversight of expenditures
- Provide legal, business and operational review and approval of outside requests for access to colleges for business continuity
- Coordinate limited return to on-campus instruction Fall 2020 semester
