I. District Updates

President Donald J. Trump's decision to rescind the Deferred Action for Childhood Arrivals (DACA) Program was announced by U.S. Attorney General Jeff Sessions on September 5. Attorney General Sessions directed the Department of Homeland Security to "wind-down" the DACA program, and signaled to Congress time to address this issue over the next six months. This ruling affects approximately 11,000 undocumented students, enrolled in the Los Angeles Community College District (LACCD). Naturally the White House action has caused anxiety and uncertainty for our students and communities. The college presidents, our Sheriff's Department, and the ESC are on high alert.

In anticipation of the announcement, executive staff worked over the Labor Day weekend to communicate our concerns to the White House, the Congress, and to prepare a message for LACCD students, staff and faculty. In addition, the following actions were taken:

Update on Chancellor's Retreat and Board of Trustees Fall Retreat

Planning for the fall Chancellor's Retreat has been finalized. The focus of the planning session is on student enrollment. The Retreat will be held on September 7 and 8 at the Van de Kamp Innovation Center, and includes presentations by Chancellor Eloy Oakley, and representatives from public higher education communications officials.

Planning for the Board of Trustees fall planning and leadership retreat will be held this weekend on Saturday, September 9, at the District Office. ACCT Vice President Narcisa Polonio is the facilitator and will lead the board through its 2017/18 goals exercise.

Legislative Update

With the State Legislature winding down its business for the 2017 Session on September 15, we have been closely monitoring the progress of two legislative measures - SB 628 (Lara) a bill making it permissible for the LACCD to go from at- large elections to district-based elections commencing in 2019, has reached the Governor's desk and we are awaiting a decision on the bill. AB 19 (Santiago) LACCD's sponsored College Promise bill made it out of the Senate Suspense File and is headed to the Senate Floor. Recent amendments requiring a future line-item budget allocation to fund the bill will increase its chances of passing the legislature. We are in conversations with the Governor's Office to address any concerns to garner his support.

New Executive Staff Members

David Salazar began his new role as the Chief Facilities Executive for the district on August 4, 2017. Mr. Salazar has extensive professional background in capital construction and facilities planning and management. Previously he served as Associate VP of Physical Planning and Facilities at Cal State, Long Beach.

Jeffrey Prieto began his role as General Counsel for LACCD on September 1, 2017. Mr. Prieto has managed the United States Dept. of Agriculture Office of General Counsel. The office is charged with providing legal services for all programs, operations and activities of the Department.

Foundation for the Los Angeles Community College District

A gift agreement for planned gift for Mike Rose has been signed by both parties. Mr. Rose agreed to allow us to announce his give to inspire others to make planned gifts. He is leaving the residual of his estate to the Foundation for an endowment to help students at Trade Tech. A press release announcing the gift is being prepared.

We had an extended meeting with Vicky Chang to review stewardship of her gift for nursing. An online form was presented to her that will make the process of distributing fund more efficient and effective. A meeting with the Chairs of each Nursing department has been scheduled.

Stewardship of gift is vital for the Foundation to build trust with donors and philanthropy foundations. A meeting to discuss parameters for grant reporting and stewardship of funds to the California Community Foundation takes place September 6. A grant report for the Edison contribution we received last spring was submitted.


II. Fall 2017 Enrollment Update


Based on the 9/4/17 enrollment report (seventh day of the semester) district-wide:

- Fall 2017 credit student headcount was at 92% of Fall 2016
- Fall 2017 duplicated enrollment was at 92% of Fall 2016
- Fall 2017 class count was at 97% Fall 2016
- Fall 2017 enrollment per class was at 95% of Fall 2016.

Fall 2017 credit headcount and duplicated enrollment continue to lag behind Fall 2016, although the gap in these measures has steadily narrowed leading up to the beginning of the semester (see charts below).

Colleges have undertaken activities to recover enrollment including contacting students with registration appointments who have not yet enrolled and analyzing closed classes to assess enrollment for high demand classes. In addition, colleges are continuing to carefully monitor and reduce low enrollment classes to ensure instructional efficiency.





III. Reports from the College Presidents

Los Angeles City College

- President Renee Martinez has announced her intent to retire at the end of the fall 2017 semester after 40 plus years as an educator at LACCD.
- The campus goal of approximately 700 fulltime enrolled First-Year Experience (FYE) students has been met. LACC has enrolled approximately 624 fulltime LA Promise students, as of 8/31/17. Developed "Last Chance Orientation Sessions" for approximately 200 students during the Beat the Rush Week.
- LACC sent letters targeting over 2,300 first Year Experience Program students, including disproportionately impacted groups of African Americans and Latinos.

East Los Angeles College

• This summer, MESA Program at ELAC offered unique opportunity to 46 highly qualified students to conduct STEM research at one of our partner institutions, ranging from University of Southern California, Purdue, and Princeton to Doheny Eye Institute and Boeing. Students worked with one or more mentors who provided guidance and monitored their progress. Research experience also included innovation and entrepreneurship elements. Participating students received a \$5,000 stipend to cover travel, accommodations and living expenses; half stipend coming from ELAC's federal grant funds and other half from the host institution. Students will present the results of their work during the ELAC's STEM Research Symposium scheduled for September 27.

 On August 17, East Los Angeles College held ELAC Live! This campus-wide effort helped over 1,478 students to access services that included on-site assistance with enrollment, registration, financial aid, walk-in counseling, course selection, EOPS, assessment, student club activities, career and employment information, financial wellness resources, and other community resources. All academic departments and ELAC programs were on hand to welcome new and returning students.

Los Angeles Harbor College

LA Harbor held two Assessment, Orientation, Counseling and Registration (AOC+R) events on campus to boost enrollment. A "Welcome Center" was opened for students comprised of Outreach, Harbor Advantage and Harbor Success.

Los Angeles Mission College

• The college has surpassed last fall's headcount and is 100% on enrollment, section, and average class size over last fall.

Los Angeles Pierce College

- LA Pierce College has been provisionally invited by the Foundation for California Community Colleges and California Community College Chancellor's Office to serve as an AmeriCorps member placement site. The program offers an exciting opportunity to complement and expand existing college efforts by placing community college students as AmeriCorps volunteers. The program is administered by California Volunteers and sponsored by the Corporation for National and Community Service.
- LA Pierce College Student Health Center has become a Medi-Cal and Family Pact provider. Family PACT is California's innovative approach to provide comprehensive family planning services to eligible low-income (under 200% federal poverty level) men and women. Family PACT serves 1.1 million income eligible men and women of childbearing age through a network of 2,200 public and private providers. Services include comprehensive education, assistance, and services relating to family planning.

Los Angeles Southwest College

Los Angeles World Airports and the HireLAX Apprenticeship Readiness Program
(ARP) (Los Angeles Southwest College and Los Angeles Trade Tech College) will
host a grand opening ceremony on September 11, 2017 at 11:00 AM, which is the first
day of class for the program. Board President Kamlager- Dove will also be present to
speak alongside the leaders of Los Angeles Southwest College, Los Angeles Trade
Technical College and Deborah Flint, CEO of Los Angeles World Airports.

Los Angeles Trade-Tech

- LA County Supervisor Hilda Solis visited the Anti-Recidivism Coalition cohort to listen about county support for a group of formerly incarcerated students that are truly turning their lives around through this pre-apprentice cohort.
- Held at the St. John's Town Hall, LATTC campus health provider and community partner celebrated the survival of individuals the Affordable Care Act and gave an update to more than 300 in attendance, including Attorney General Javier Becerra.

- LACCD asked LATTC to host business leader, philanthropist, and environmentalist Tom Steyer. Chancellor Rodriguez, President Frank and Anti- Recidivism Coalition founder and CC Board of Governors member Scott Budnick joined Steyer in speaking with ARC students about being incarcerated and turning their lives around at the LA Trade Tech partnership program.
- Entire LATTC faculty returned for their annual gathering before the fall semester starts
 to talk about the upcoming school year. Speakers included new LACCD Board of
 Trustees member Gabriel Buelna. Faculty leaders agreed to take the lead in a twoday enrollment fair for the community.
- More than 140 students gathered to hear information about UMOJA, a group that focuses on the success of African-American and other students as they move forward on their educational journey.
- Congresswoman Karen Bass and Former Mayor Villaraigosa spoke to 80+ students about concerns related to continuation of DACA.
- More than thirty members of the Anti-Recidivism Coalition class, were honored at their graduation and celebration as they launch into their construction jobs. Partners including the LA County Fed's Rusty Hicks, LA/OC Building Trades President Ron Miller, Chancellor Francisco Rodriguez, ARC founder Scott Budnick, and President Larry Frank were in attendance to celebrate the group of formerly incarcerated students. Actor Danny Trejo also attended and addressed the class with words of encouragement. Trejo's nephew graduated with the group.

Los Angeles Valley College

On August 22, the LAVC Foundation held its annual Scholarship event, where 153 students were awarded scholarships totaling \$104,750. More scholarships will be awarded later in the year. LAVC was pleased to learn on August 31 that it's federal Upward Bound: Math and Science grant was approved for \$263,938 per year for a total of \$1,319,690 over five years. This grant will extend their current grant-funded program through 2022.

West Los Angeles College

- WLAC's Associate in Computer Science Information Technology program has been ranked in the top twenty (#19) among similar programs in the U.S. In a review of schools across the nation, WLAC's program stood out in both quality and affordability.
- WLAC opened its Welcome Center on the main floor of the Student Services Building.
 During the first two weeks of operation, they averaged 100 contacts a day. Traffic increased dramatically with the opening of the semester.
- WLAC was selected as a participant in a study by The National Academies of Sciences, Engineering and Medicine: "Closing the Equity Gap, Securing our STEM Education and Workforce Readiness Infrastructure in the Nation's Minority Serving Institutions."
- WLAC has received notification that its Upward Bound Math and Science grant has received funding for the next five years.
