13	Please describe the current staffing structure for the Districts' WC claims program? Are all adjusters dedicated exclusively to the District?	One (1) Account Manager, two (2) Senior Examiners, one (1) Future Medical Examiner, and one (1) Assistant. Adjusters are not dedicated.
14	Can the District provide a current loss run detailing 3-5 years of loss history including all open claims?	This RFP is for General TPA Services. Please provide your best proposal and bid based on the information provided in the RFP.
