Project Description: Los Angeles Community College District (LACCD) has owned the property located at 9700 S. Sepulveda Boulevard in the City of Los Angeles, California (APN 4124-026-900) (Project Site) since 1954. There are four buildings on the Project Site used for storage with the remainder of the site used for commercial parking. LACCD is selling the property at fair market value to the City of Los Angeles (acting by order of and through its Board of Commissioners for Los Angeles World Airports [LAWA]) under the threat of condemnation. LAWA intends to later construct an elevated roadway on the Project Site, as part of and in conjunction with LAWA's larger Airfield and Terminal Modernization Project (ATMP) of Los Angeles International Airport (LAX). The LACCD action is limited to the proposed sale of the entire site to LAWA (collectively, the proposed Project). LAWA, as a public entity, will assume ownership and management of the Project Site following any sale.

LACCD, as a responsible agency, has reviewed the ATMP EIR (State Clearinghouse Number 201904020) and Addendum previously approved by LAWA as the lead agency on October 7, 2021 and January 16, 2025 (respectively) and each of the mitigation measures and alternatives identified in the EIR.

On March 5, 2025 the Board of Trustees of the Los Angeles Community College District (Responsible Agency) has:

- Adopted a resolution making responsible agency findings based on the Airfield and Terminal Modernization Project Environmental Impact Report for the proposed surplus land act determination; proposed approval of an agreement regarding variance, access and due diligence; and sale of the property located at 9700 S. Sepulveda Boulevard;
- Adopted a resolution approving an agreement regarding variance, access, and due diligence with the City of Los Angeles (acting by order of and through its Board of Airport Commissioners; and

Adopted a resolution declaring the disposition of property located at 9700 S. Sepulveda Boulevard "Exempt Surplus Land" for transfer to another agency under the California Surplus Land Act.

On March 5, 2025 the Board made the findings below, and on September 10, 2025, took further action to authorize the sale of the property to LAWA:

- Adopted a resolution authorizing the sale of surplus real property located at 9700 S. Sepulveda Boulevard to the City of Los Angeles, a California Municipal Corporation (acting by order or and through its Board of Airport Commissioners (BOAC), a public agency.

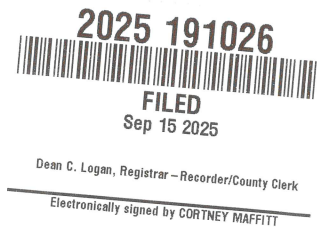
